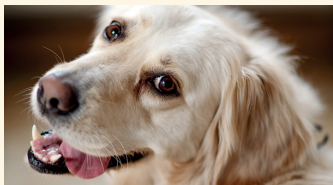


We'll do anything for your pet: Registering is quick and easy

Additional registration information

Information on registration

1. Registration in the central pet-database of TASSO e.V. is free of charge to the pet owner. The pet owner will incur no follow-up costs. TASSO e.V. finances its activities through voluntary donations. Should you wish to support TASSO e.V. in its diverse activities in the area of animal protection, a corresponding form is included with any kind of written correspondence.
2. Data communicated to the central pet-database is subject to data protection (for details please refer to the paragraph on "Comments on Data Protection").
3. As soon as the relevant data has been recorded with the central pet-database of TASSO e.V., the pet owner receives by mail free confirmation of the registration, a pet identification card and an SOS collar tag.
4. **IMPORTANT:** TASSO e.V. cannot assume liability for any registration forms lost when sent by regular mail. Therefore, should you not have received your confirmation of registration 3 weeks after submitting your request, please contact the TASSO emergency hotline in order to ensure that your pet has been registered properly.
5. Twice a year, the pet owner receives a free copy of the official information magazine published by TASSO e.V. containing information on current animal protection topics and the animal protection activities of TASSO e.V.

Comments on data protection

1. Data that is recorded in the central pet-database of TASSO e.V. include address data of the respective pet owner and (if provided) the related telephone number, cell phone number, fax number and e-mail address as well as data required for identification of the relevant pet.
2. With the agreement of the pet owner, the data is collected for the following purposes:
 - a) Returning of the pet in the case of loss / find.
 - b) Semi-annual delivery of a free copy of the official information magazine published by TASSO e.V. (Information on current animal protection topics and the animal protection activities of TASSO e.V.). This service can be refused. The pet owner is then not receiving information on animal protection.
3. For the purpose of returning the pet, the pet owner's data may be passed on to persons who have found the pet (this also includes animal protection societies, animal shelters or veterinary practices). In exceptional cases the circulation of data may lead to the previous owner should the new ownership not have been communicated to the central pet-database of TASSO e.V. by the new or old pet owner or, as the case may be, should such a new registration of the pet still be in process due to mail delivery time or for similar reasons. The pet owner will receive up-to-date information about the circulation of his/her data.
4. In an emergency situation for the pet (e.g. when it is in need of urgent medical attention), data on the pet owner may also be circulated without the pet owner being informed.
5. In any cases other than those mentioned under 3. and 4. above, circulation of data is not permitted.
6. The applicant may refuse the forwarding of his/her data to private finders, animal protection societies, animal shelters and vets.
7. The applicant may also refuse the forwarding of his/her data in emergency situations (refer to 4.). However in this case in an emergency it may not be possible to help the pet.
8. Should the applicant pass his/her pet on to a third party or sell it, this must be reported to TASSO e.V. Should the pet have been passed on to a third party and not have been re-registered properly, no liability can be assumed for the possible incorrect circulation of data. Likewise, no liability can be assumed for reregistrations that are being processed or, as the case may be, have not yet been processed (mail delivery times or processing times after receipt at the central pet-database of TASSO e.V.).
